- Both the institutions undertake to promote and develop cooperation with various activities such as those listed below based on equality and reciprocity:
  - 1.1 Exchange and sharing of the students and faculty members of both the institutions.
  - 1.2 Hosting seminars, talks, panel discussion conducting survey, field work, book fair, sports activity, and various other extension activities for academic excellence jointly in both the institutions.
  - 1.3 Students of both the institutions will have equal access to quality enhancement programmes organized at both the institutions.
- 2. It is understood that implementation of any of the type of cooperation stated in clause 1.2 mentioned above shall depend upon the availability of resource and financial support at the institutions concerned.
- 3. This Agreement shall remain in force for five years unless either institution terminates it by a minimum of a six month's written notification to the other institution.
- 4. This agreement may be extended after discussion by the representatives of both the institutions.
- The agreement may any time be revised or modified, by mutual consent, within the period agreed upon by way of clause 3 and/or 4 mentioned above.
- 6. Both the institutions jointly agree that the original copy of the instant Agreement shall remain in the custody of "Rani Birla Girls' College" and a Duplicate copy of this Agreement, which will be signed in original and executed on the same day and at the same time with Original copy by both the Institutions shall remain in the custody of "Dum Dum Motificel College" and the said Duplicate copy of Agreement will be treated and considered as good as Original and also will bear the same legal value as the said Original copy of Agreement.
